1. PREFACE

The Independent Communications Authority of South Africa ("the Authority") has a statutory mandate in terms of the Constitution, the ICASA Act and the Electronic Communications Act of 2005 ("EC Act") to regulate broadcasting activities in South Africa in the public interest. One of the main tasks of the Authority is to ensure compliance by broadcasters with the terms and conditions of their licence, the Electronic Communications Act, the ICASA Act, any relevant legislation and regulations.

The purpose of the report is to give account of 94.7 Highveld Stereo's compliance with the terms and conditions as set out in its licence for the 2019/2020 financial year. Aspects of compliance that are measured comprise of Geographic Coverage, Broadcasting Languages, Format, General Programming Obligations, Training and Skills Development, Community-Related Obligations, Ownership and Control, South African Music Regulations, Regulations Regarding Standard Terms and Conditions, Universal Service and Access Fund (USAF) Regulations and the ICT Covid-19 National Disaster Regulations¹ first published in April 2020 and the subsequent amendments following the proclamation of the State of National Disaster.

The ICT Covid-19 National Disaster Regulations as amended have introduced exemptions with specific service licence conditions and/or revised quotas and such will be reflected in the body of the report accordingly.

2. BACKGROUND

In December 2008, the Authority issued Primedia ("the Licensee") with an Individual Commercial Sound Broadcasting Service licence² and a Radio Frequency Spectrum licence³ in terms of the EC Act.

The Licensee broadcasts as 94.7 Highveld Stereo and provides a service in the Gauteng province. The radio station is broadcasting from the studios situated at 5 Gwen Lane, Sandown, Sandton. The signal distribution service is conducted by Sentech (Pty) Ltd.

3. COMPLIANCE ASSESSMENT

3.1. Control Structure

3.1.1. Ownership and Control

Clause 1 of 94.7 Highveld Stereo's licence provides that:

"The licence is issued to:

1.1 Name of Company/Entity: Primedia (Pty) Ltd

1.2 Shareholders: Mineworkers Investment Company - 46.61%

Kirsh Consortium - 23.8%

Brait Entities - 18.84%

Management Stake - 5%

Titan Share Dealers - 2.86%

Sabvest (together with BPESAM 1 Ltd

BPESAM II Ltd - 0.99%

KV and GR Direct - 1.9%

1.3 Ownership held by persons from historically disadvantaged groups: 46.61%"

During the period under review, there were no changes reported by the Licensee to its name, shareholding and HDG structure.

The Licensee complies with clause 1 of its licence.

The Licensee did not submit any notification with regards to all the above as stated during the period under review.

The Licensee complies with clause 2 of its licence.

3.3 Notices and Addresses

Clause 3 of the licence provides that:

The Licensee did not submit any notification in terms of its principal addresses during the period under review.

The Licensee complies with clause 3 of its licence.

3.4 Name of Station

Clause 1 of the schedule to 94.7 Highveld Stereo's licence provides that:

"Name of Station: 94.7 Highveld Stereo".

There were no changes reported by the Licensee to its name during the period under review.

The Licensee complies with clause 1 of the schedule to its licence.

3.5 Geographic Coverage Area

Clause 2 of the schedule to 94.7 Highveld Stereo frequency spectrum licence provides that 94.7 Highveld Stereo's geographic coverage area to be as follows:

"Southern Gauteng, as defined in the coverage map attached to the Licensee's radio frequency spectrum licence".

The Authority did not receive reports suggesting the Licensee broadcasts outside the defined coverage area.

The Licensee complies with clause 2 of the schedule to its licence.

3.6 Broadcast Language (s)

Clause 3 of the schedule to 94.7 Highveld Stereo licence provides that the language of broadcast shall be:

"Principal Language: English".

94.7 Highveld Stereo broadcast its programmes in English as its primary language.

The Licensee complies with clause 3 of the schedule 3 to its licence.

3.7 Format

Clause 4 of the schedule to 94.7 Highveld Stereo's licence provides that the Licensee is:

"The Licensee shall have a programming mix of talk and music in an adult contemporary format, providing a mix of music and information (including coverage of community affairs)".

The Authority's monitoring exercise found that the Licensee broadcasts a programming mix of talk and music in an adult contemporary format which includes coverage of community affairs as required by the clause above.

The Licensee complies with clause 4 of the schedule to its licence.

3.8 Local Content Obligations

Clause of the schedule to 94.7 Highveld Stereo's licence provides that:

"The Licensee shall promote at least eight (8) local music concerts per annum and allocate airtime for the broadcasting thereof".

Sound broadcasting Licensees were exempt from compliance with specific programming requirements and promises of performance during the National State of Disaster. Therefore, findings on compliance with this clause of the licence were not made/determined.

3.9 General Programming Obligations

Clause 6.1 of the schedule to 94.7 Highveld Stereo's licence provides that:

"The Licensee shall broadcast a minimum of thirty (30) minutes of news per day between 05h00 and 23h00 during weekdays".

The the monitoring exercise revealed that 94.7 Highveld Stereo broadcast news at the top of every hour during the Performance Period, daily.

The Licensee broadcast approximately forty-nine minutes of news per day during Performance Period. The following were among the news items identified during the period under review:

- "Former President Jacob Zuma has left the state capture inquiry without permission. This comes in the wake of Deputy Chief Justice Raymond Zondo dismissing the former president's application for recusal on the grounds that Zuma failed to meet the test for a reasonable apprehension of bias.";
- "President Cyril Ramaphosa has moved the country to alert Level 4 lockdown, with stricter restrictions from Monday. The Ministerial Advisory Committee advised that the limited restrictions previously imposed are not effective."; and
- "Four weeks after COVID-19 hit South Africa, the country had to come to terms with a very different reality. From restrictions on our movement to measures to help businesses, which will be gutted by the nationwide lockdown, these are extraordinary times.";

Sound broadcasting Licensees were exempt from compliance with specific programming requirements and promises of performance during the National State of Disaster. Therefore, findings on compliance with this clause of the licence were not made/determined.

Clause 6.2 of the schedule to 94.7 Highveld Stereo's licence provides that:

"The source(s) of all news material (other than news sourced from the Licensee) shall be disclosed during the news broadcast".

The monitoring exercise revealed that most of 94.7 Highveld Stereo's news bulletins are sourced from Eyewitness News, a subsidiary of Primedia (Pty) Ltd, as well as its US, UK and Africa correspondents. It was however not confirmed whether the Licensee discloses sources of news whenever it reports news obtained from other sources other than itself.

Sound broadcasting Licensees were exempt from compliance with specific programming requirements and promises of performance during the National State of Disaster. Therefore, findings on compliance with this clause of the licence were not made/determined.

3.10 Training and Skills Development Obligations

Clause 7 of the schedule to 94.7 Highveld Stereo licence provides that:

"The Licensee shall over its licence period, allocate R350 000 (three hundred and fifty thousand Rand) per annum to training and development, particularly of staff from historically disadvantaged groups".

The Licensee submits that it delivered a few different training interventions at a cost of R4 107, 420.66 (four million one hundred and seven thousand four hundred and twenty Rand sixty-six cents). Of which R4, 055, 326.00 (four million and fifty-five thousand three hundred and twenty-six Rand) of the training spend was spent on training staff from historically disadvantaged groups.

The Licensee complies with clause 7 of the schedule to its licence.

3.11 Community - related Obligations

Clause 8.1 provides that:

"The Licensee shall:

8.1.1 raise at least R250 000.00 (two hundred and fifty thousand Rand) in cash and goods annually".

The Licensee submits that in the period under review, it contributed to the communities in its coverage area through supporting various causes in the communities to a tune R,1,080,000 (one million and eighty thousand Rand) in cash and goods as illustrated in the table below:

The Licensee complies with clause 8.1.1 of the schedule to its licence.

8.1.2 provide airtime worth R250 000 (two hundred and fifty thousand Rand) annually, towards supporting community organisations such as those benefiting:

- a) people infected or affected by HIV & AIDS:
- b) the terminally ill and/or the elderly:
- c) schools;
- d) women;
- e) children;
- f) animal welfare; and or
- g) natural/environmental disasters such as fires and floods".

The Licensee submits that in the period under review, it conducted interviews and did a broadcast of public service announcements (PSAs) for various organisations amounting to an airtime value of R2,374,179,80 (two million three hundred and seventy-four thousand one hundred and seventy-nine Rand and eighty cents).

The table below illustrates the licensee's performance with its obligation.

The Licensee complies with clause 8.1.2 of the schedule to its licence.

Clause 8.2 provides that:

"The Licensee shall train staff from community sound broadcasting services in its geographic coverage area in the areas of: programme presenting and production, news, sales, marketing and sound engineering through mentoring and on-the-job training that is, having such staff "shadow" 94.7 Highveld Stereo presenters, producers, news reporters, sales representatives, marketing staff and sound engineers while at work". The Licensee submits that due to prevailing COVID-19 Regulations, it was unable to conduct any staff training for community sound broadcasters.

The Licensee did not comply with clause 8.2 of the schedule to its licence.

Clause 9 provides that:

"Directors of the Licensee shall retain control and responsibility for the running of the station notwithstanding the provisions of any management consultancy services engaged by the Licensee".

The Licensee's submission does not carry any change on its control structure nor has the Authority been notified of any change is the Licensee's directorship.

The Licensee complies with clause 9.2 of the schedule to its licence.

4. **REGULATIONS**

4.1 Complaints

The Licensee is required, in terms of the Compliance Procedure Manual Regulations, to submit a Form 12A which reports on all complaints received during the period under review.

The Licensee has submitted details regarding the above regulation and how it accordingly resolved the issues raised therein.

The Licensee complies with the Compliance Procedure Manual Regulations in relation to complaints.

4.2 SA Music Content

The Authority published the ICASA South African Music Contents Regulations which repealed the ICASA South African Music Content Regulations, 2006. The Regulations were to be effective eighteen (18) months after publication i.e. 23 September 2017 which falls within the period under review. The quotas where revised from 25% to the 35% for commercial sound broadcasting services.

Regulation 3 (2) of the ICASA South African Music Contents Regulations stipulates that:

"Every holder of a commercial sound broadcasting licence must ensure that after eighteen (18) months from the date of gazetting of these Regulations, a minimum of 35% of the musical works broadcast in the performance period consist of South African music and that such South African music is spread reasonably evenly throughout the said period".

During the year under review, the monitoring exercise revealed that 94.7 Highveld Stereo played an average of 35% (twenty five percent) of South African Music spread reasonably evenly throughout the Performance Period. The South African artists featured included among others, Jeremy Loops, Jimmy Nevis, The Kiffness & Ami Faku, DJ Kent, Prince Kaybee etc.

The Licensee complies with regulation 3.2 above.

4.3 Standard Terms and Conditions

During the year under review, the Authority did not identify instances of non-compliance by the Licensee with the Regulations regarding Standard Terms and Conditions for Individual Licences⁴.

The Licensee complies with the above Regulations.

4.4 Regulations in respect of the Prescribed Annual Contributions of Licensees to the Universal Service and Access Fund

Regulation 3 (1) of the Regulations in respect of Prescribed Annual Contributions of Licensees to the Universal Service and Access Fund (USAF)⁵, as published in the Government Gazette, No. 31499 of April 2009, stipulates that:

"Every holder of a Licence granted in terms of Chapter 3 or converted in terms of chapter 15 of the Act, must pay an annual contribution of 0.2% of the annual turnover, derived from the licensee's licence activity, to the Fund (the Fund)".

Further, Regulation 3 (3) stipulates that:

"A broadcasting service licensee who has paid an annual contribution to the Media Development and Diversity Agency (MDDA) must set off that contribution against its prescribed annual contribution to the Fund"

94.7 Highveld Stereo's financial year ends on 30 June. The Licensee has issued correspondence regarding the payment of the Universal Service and Access Fund. The Licensee has given an undertaking to make the payment as required by the regulations.

The Licensee partially complies with the above regulations.

4.5 General Licence Fees Regulations

Regulation 3 (1) of the General Licence Fees Regulations⁶ provides that:

"The annual Licence fees prescribed in these regulations and as set out in schedule 2 apply to holders of individual and class ECS Licences, individual and class ECNS Licences and individual commercial Broadcasting Licences".

Schedule 2 of the Annual Licences Fees regulations provides for Licensees to pay an annual licence fee in accordance with their licensed revenue and to be calculated using the set formula, read with the applicable percentages.

Regulation 7(a), 7(b) and 7(c) of Schedule 3 provides that:

a) Are due annually based on the licensee financial year;

b) Are due and payable within 6 months from the end of the end of the licensee's financial year;

c) May only be paid by way of an electronic transfer or via direct deposit into the Authority's bank account".

94.7 Highveld Stereo's financial year ends on 30 June. The Licensee has paid its licence fees on 30 October 2020 and submitted proof of payment⁷ thereof, as required by the Regulations.

The Licensee complies with the above regulations.

5. CONCLUSION

The exemptions and suspensions imposed on Licensees due to the National State of Disaster have been lifted for the next review period. Complete monitoring of compliance with licence conditions and regulations will be conducted in the next review.
