**APPLICATIONS FOR THE RENEWAL OF INDIVIDUAL COMMERCIAL SOUND
BROADCASTING SERVICE AND RADIO FREQUENCY SPECTRUM LICENCES
BY RHYTHM (PTY) LTD TRADING AS RHYTHM FM**

1. On 09 June 2026, the Authority issued a Notice in the *Government Gazette* No. 54816 inviting written representations and responses in relation to the applications from Rhythm (Pty) Ltd ("the Applicant"), for the renewal of its Individual Commercial Sound Broadcasting Service ("I-CSBS") and Radio Frequency Spectrum (RFS) Licences.
2. Interested persons were invited to submit written representations within fourteen (14) working days from the date of publication of the Notice in the *Government Gazette* (i.e., on 30 June 2026). Written responses were required to be lodged with the Authority within twenty-eight (28) working days from the date of publication of the Notice in the *Government Gazette* (i.e., on 20 July 2026).
3. **The Authority hereby extends the deadline for the submission of written representations to 02 July 2026, and the submission of written responses by the Applicant to 22 July 2026.**
