

3. PROPOSED AMENDMENT TO THE LICENCE

3.1 Set out the proposed amendment/s and attach a copy of the radio frequency spectrum Licence marked clearly as **Annexure A** of **FORM A 2**:

Telkom proposes the following amendments to its 2300/2400 spectrum licence:

Schedule B of the licence:

- a. Section 1 (TYPE OF RADIO FREQUENCY LICENCE), remove the reference to "2400" as follows: "2300/~~2400~~ MHz Radio Frequency Spectrum"
- b. Section 5 (RIGHT TO USE THE 2300/2400 MHz RADIO FREQUENCY SPECTRUM), remove the reference to "2400" in the title as follows: "RIGHT TO USE THE 2300/~~2400~~ MHz RADIO FREQUENCY SPECTRUM"
- c. Section 6 (GENERAL CONDITION):
 - i. In section 6.5, remove the reference to "TDD" as follows: "The ~~TDD~~ radio frequency spectrum is assigned..."
 - ii. Deleted section 6.6

Schedule C of the licence:

- a. In row 2 of the table, amend the frequencies associated with the 2300 MHz band as follows: "2300 – ~~2360~~ 2387 MHz (TDD)"
- b. In row 3 of the table, amend the bandwidth associated with 2300 MHz band as follows: "~~60~~ 87 MHz TDD spectrum"
- c. Delete all four rows associated with the "2300/2400 MHz band".

The above proposed amendments (Schedule C) to the table are also reflected below:

Bandwidth:	60 <u>87</u> MHz TDD Spectrum

Bandwidth:	80 MHz FDD spectrum
Area of Operation:	National

Since all PTMP/TDMA FWA systems that operated in the 2300/2400 MHz band have been migrated to, amongst others, the 2300 MHz LTE network, the licence amendment can be implemented immediately.


