	The purpose of the submission was to table the recommendation by Complaints and Compliance Committee in the matter between Anthony Duke and Five Others and Whale Coast FM.	
	On the 23 April 2018, the CCC received a complaint in terms of Section 17B(a) of the Independent Communications Act of South Africa (ICASA) act 13 of 2000, to investigate and hear if appropriate, and make a finding on allegations of non-compliance against Whale Coast FM. The Complaints allege that Whale Coast FM has failed to comply with the following licence conditions of its Class Broadcasting Licence:	
	 Clause 1.3. Control Licensee: "Control shall vest in the governing body of Breakthrough Adventures NPC". 	
	• Clause 4.2. "The Licensee shall provide for the	

- participation of community members in the affairs of the station in the following ways:
- 4.2.1 The Licensee shall hold at least two (2) meetings annually with its community focusing on programming policies of the station.
- 4.2.2 The Licensee shall furnish the Authority with proof of such meetings as well as the attendance thereof by members of the community.
- 4.2.3 The Licensee shall hold Annual General Meetings (AGM) for the following purposes:
 - 4.2.3.1. To provide feedback on the Licensee's compliance with licence conditions;
- 4.2.3.2 To provide feedback on the Licensee's operational and financial performance, and any Special Annual General Meeting as and when required by the constitution; and
- 4.2.3.3 To elect members of the controlling structure e.g. Board of Directors, Trustees etc. subject to the licensee's founding documents.
 - Clause 8.1. "The Licensee

shall provide for the participation of community members in the affairs of the station in the following ways:

2. South African Post Office SOC Ltd (SAPO) Annual Tariff Application for 2019/2020 Price Control Period and Amendment Proposal Submission

The purpose of the submission was for Council to:

- Approve and average decrease of 0.5% (which amounts to -R 13.37 million) in revenue for reserved postal products and services; and
- Approve SAPO's request to discontinue surface mail destined for African countries and a single rate for outbound mail destined for African countries.

It was resolved that the South African Post Office SOC Ltd (SAPO) Annual Tariff Application for 2019/2020 Price Control Period and Amendment Proposal Submission be approved.

3. Radio Frequency Spectrum Assignment Plan for the Frequency Band 825 to 830 MHz and 870 to 875 MHz

The purpose of the submission was to request Council to:

 Note that the Authority's Strategic Plan 2016/2017 – 2021 Strategic Objective is to increase access to broadband spectrum from 566MHz to 958MHz by 2020. It was resolved that the Radio Frequency Spectrum Assignment Plan for the Frequency Band 825 to 830 MHz and 870 to 875 MHz be approved.

- Note that the Radio Frequency Spectrum Assignment Plan for the International Mobile Telecommunication for the Frequency band 825 to 830 MHz and 870 to 875 MHz, (IMT850) is to be published during the first quarter of 2018/19 financial year.
- Note that the finalisation of the IMT850 forms baseline а document for the assignment process that is taking place through an Invitation to Apply which includes all the IMT700 and IMT800, in terms the Radio regulation7 of Spectrum Frequency Regulations.
