FORMAT</p> <p>(a) The Licensee shall have a format that is 60% music and 40% talk.</p> <p>(b) Of the music broadcast, the single largest genre featured on the music playlist shall be gospel.</p> <p>(c) Of the talk broadcast, a minimum of 15 hours a week shall be gospel/spiritual-related.</p> <p>We make application to amend clause 5 such that it reads:</p> <p>5. LOCAL CONTENT OBLIGATIONS</p> <p>40% of the music broadcast shall be South African music, measured on a weekly basis.</p>

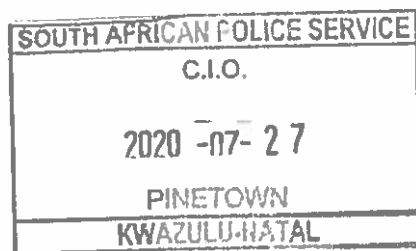
