1. The Independent Communications Authority of South Africa ("ICASA / the Authority") hereby gives notice of oral hearings on the Supplementary Discussion Document issued for the Inquiry into Subscription Television Broadcasting Services ("the Inquiry") in accordance with Section 4B of the Independent Communications Authority of South Africa Act, 2000 (Act No. 13 of 2000), read with section 67(4) of the Electronic Communications Act, 2005 (Act No. 36 of 2005).
2. The Authority published the Supplementary Discussion Document on the Inquiry into Subscription Television Broadcasting Services in Government Gazette No. 51848 on 06 January 2025. Following requests from stakeholders, the deadline for submissions was extended from 10 March 2025 to 24 March 2025.
