BROADCASTING SERVICE LICENCE BY YOU FM (PTY) LTD T/A YOU FM**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from You FM (Pty) Ltd t/a You FM ("the Applicant"), for the amendment of its Individual Commercial Sound Broadcasting Service ("I-CSBS") Licence.
2. The amendment application of the Applicant's I-CSBS licence is lodged in terms of section 10 (1) of the Electronic Communications Act No. 36 of 2005 as amended ("the EC Act") read with regulation 9 of the Processes and Procedures Regulations for Individual Licences and Temporary Authorisation of 2010, as amended and regulation 9 of the Radio Frequency Spectrum Regulations, 2015, as amended.
3. In terms of section 10(2) read with section 9(2) of the EC Act, the Authority is required to give notice of the application in the Government Gazette and invite interested persons to submit written representations in relation to the application.
4. Further, section 9(2)(c) of the EC Act requires that the Authority must set out the proposed licence conditions that will apply to the licence.
5. The application seeks the approval of the Authority to amend it's I-CSBS Licences as follows:

6. The application for amendment and any representations received pursuant to this notice, will be made available to any interested party on the Authority's website: www.icasa.org.za.
7. Any interested party is invited to lodge written representations in relation to the application within fourteen (14) working days from the date of publication of this notice in the Government Gazette.
8. Persons who lodge representations must also indicate whether they wish to make oral submissions should the Authority decide to hold a public hearing in respect of the application.
9. The written responses must be lodged with the Authority within twenty-eight (28) working days from the date of publication of this notice in the Government Gazette.
12. The Applicant must, at the time of lodging the written response/s, furnish proof to the Authority's satisfaction that it has delivered a copy of such response/s via

email **OR** by hand to the relevant person/s having made the written representation.
