**ELECTRONIC COMMUNICATIONS ACT, 2005 AS AMENDED (ACT NO. 36 OF 2005)****PUBLIC HEARING WITH REGARDS TO THE APPLICATION FOR THE
AMENDMENT OF THE INDIVIDUAL COMMERCIAL SOUND BROADCASTING
SERVICE LICENCE BY HOT 1027 FM (PTY) LTD T/A HOT 1027 FM**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has decided to hold a public hearing on 14 May 2025 with regard to an amendment application of the Individual Commercial Sound Broadcasting Service ("I-CSBS") Licence submitted by Hot 1027 FM (Pty) Ltd t/a Hot 1027 FM ("the Applicant").
2. On 02 September 2024, DLA Piper Advisory Services Proprietary Limited lodged an application for the amendment (Form C) of the Applicant's I-CSBS licence in terms of section 10 (1)(a), (b), (c), (d) and (f) of the Electronic Communications Act, 2005 (Act No. 36 of 2005), as amended ("the EC Act").
3. The amendment application of the I-CSBS licence is lodged in terms of section 10 (1) of the Electronic Communications Act, 2005 (Act No. 36 of 2005), ("the EC Act") read with Regulation 9 of the Processes and Procedures Regulations for Individual Licences¹, 2010, as amended.
4. The Applicant seeks the approval of the Authority to amend clause 5 (Format) of its I-CSBS licence. The current format for the Applicant is 50% Classic Music and 50% Old Skool and R&B Music.
5. The Applicant proposes to broadcast 100% Old Skool and R&B Music and remove Classical Music.

6. On 20 November 2024, the Authority published a Notice² in the *government gazette* inviting interested parties to submit written representations in relation to the application within fourteen (14) working days from the date of publication of the notice.
7. The closing date for written representations was on 10 December 2024.
8. On 09 December 2024, the Applicant and the Authority received one (1) written representation from the South African Broadcasting Corporation ("SABC").
9. The closing date for the written responses was on 03 January 2025 (twenty-eight (28) days from the date of the publication of the Notice). On even date, the Applicant responded to the SABC's written representation.
10. The agenda for the public hearing is attached as "Annexure A" below.
