**Johannesburg** – The Independent Communications Authority of South Africa ("ICASA") will hold public hearings in respect of applications received for the licensing of individual commercial free to air television broadcasting services. This is in response to an invitation to apply (ITA) published in the government gazette on 29 August 2014.
