RE-OPENING OF SUBMISSIONS FOR WRITTEN REPRESENTATIONS ON THE NOTICE OF INTENTION TO CONDUCT AN INQUIRY ON THE EFFECTS OF LOAD SHEDDING AND THE REGULATORY RELIEF MEASURES THE AUTHORITY MAY CONSIDER AS IT SEEKS WAYS TO ALLEVIATE THE IMPACT OF LOAD SHEDDING IN THE ELECTRONIC COMMUNICATIONS, BROADCASTING, AND POSTAL SECTORS

- 1. The Independent Communications Authority of South Africa (the "Authority") hereby gives notice that the period for submitting written representations on Annexure A published in the Notice of Intention to Conduct an Inquiry on the Effects of Load Shedding and the Regulatory Relief Measures the Authority may consider as it seeks to alleviate the impact of load shedding in the electronic communications, broadcasting and postal sectors (Government Gazette No. 49795 of 01 December 2023) is hereby re-opened, from the date of publication of this Notice, until no later than 16h00 Friday, 01 March 2023.
- 2. The re-opening of submissions for written representations is undertaken to afford all stakeholders adequate time to answer the series of questions in Annexure A of the aforementioned Notice.
- 3. Stakeholders who submitted written representations by 08 February 2024 are not required to resubmit. However, all stakeholders may elect to use this
