

## AMENDMENT OF THE INVITATION TO APPLY FOR A RADIO FREQUENCY SPECTRUM LICENCE TO PROVIDE MOBILE BROADBAND WIRELESS ACCESS SERVICES FOR URBAN AND RURAL AREAS USING THE COMPLIMENTARY BANDS, 700MHz, 800MHz AND 2.6GHz.

- On 15 July 2015, the Independent Communications Authority of South Africa ("the Authority"), in Government Gazette number 40145 (Notice Number 438 of 2016), published a notice (Invitation to Apply) in terms of Section 31(3) (a) of the Electronic Communications Act, 2005 (Act No. 36 of 2005), as amended, read with regulations 6 and 7 of the Radio Frequency Spectrum Regulations 2015 ("the Regulations"), published in Government Gazette number 38641 (Notice number 279 of 2015), inviting applications for the radio frequency spectrum licenses within the designated range, 2500 – 2690MHz ("the 2.6GHz band") and 790 – 862 MHz ("the 800 MHz band") and 694 – 790 MHz ("the 700MHz band") for the purposes of providing national broadband wireless access services.
- Interested persons were invited to submit their applications, including an electronic version of the application in Microsoft Word, on the Invitation to Apply for a Radio Frequency Spectrum Licence to provide Mobile Broadband Wireless Access Services for Urban and Rural areas using the complimentary bands, 700 MHz, 800 MHz and 2.6 GHz.
- 3. The Authority has resolved to amend the Invitation to Apply (ITA) to the extent reflected in the

#### Amendment of paragraph 1 of the ITA

2. Paragraph 1 of the ITA is hereby amended by the substitution for the definition "application date" after the definition "application" with the following definition:

"Application Date 03/02/2017: Due date for the receipt of Applications"

#### Substitution of paragraph 10 of the ITA

3. The following paragraph is hereby substituted for paragraph 10 of the ITA:

#### Insertion of item 47A (Paragraph 8) in the ITA

- 4. The following item is hereby inserted in the ITA, after item 47:
  - "47A. In an instance where 100% of the spectrum is not available on a nationwide basis in a Lot due to analogue broadcasting services that have not fully migrated, then the obligation in terms of item 47 will be deferred until such time that the licensee has access to 100% of the spectrum in the assigned Lot."

#### Amendment of item 67 (Paragraph 12) of the ITA

- 5. Item 67 of the ITA is hereby amended by the substitution for sub-item 67.2 of the following sub-item:
  - "67.2 Have a minimum 30% (thirty percent) equity ownership held by persons from Historically Disadvantaged Groups; alternatively, in instances where an Applicant does not have such 30% equity ownership, must be a level 4 and above contributor (BBBEE status) in terms of the Codes of Good Practice published in terms of section 9(1) of the BBBEE Act."

#### Amendment of item 70 (Paragraph 12) of the ITA

6. Item 70 of the ITA is hereby amended by the deletion of the words "(i.e. Mon 03/10/2016)" after the words "application date".

#### Substitution of item 74 (Paragraph 12) of the ITA

- 7. The following item is hereby substituted for item 74 of the ITA:
  - "74. The closing date for receipt of applications is Friday 03/02/2017 at 15:00.

#### Substitution of item 75 (Paragraph 12) of the ITA

- 8. The following item is hereby substituted for item 75 of the ITA:
  - "75. Each Applicant must pay an application fee of Three Million Rand (ZAR 3 000 000.00), which is refundable on condition that the ITA is set aside by a Court of law. The payment must be in the form of an electronic transfer or via a direct deposit into the following ICASA bank account:"

9. The following item is hereby substituted for item 75 of the ITA:
