REGIONS AND CONSUMER AFFAIRS DIVISION OF ICASA (RCA) AND MR ANVIL D NEL (MR. NEL) V SOUTH AFRICAN POST OFFICE (SAPO) CASE NUMBER: 491/2025

The above matter has reference.

- On 18 February 2025, RCA lodged a postal complaint with the CCC against SAPO for investigation in terms of section 17B(a) of the Independent Communications Authority of South Africa ("ICASA") Act No. 13 of 2000.
- 2. The CCC adjudicated the matter on 18 July 2025 and 25 September 2025, and made the following findings:
 - (a) Regulation 5.1 states that: "The conveyor is deemed to possess the mail from the moment that mail is handed to the conveyor or his agent." The charge is dismissed.

(b) Regulation 5.2 states that: "Possession of mail passes to the addressee,

upon delivery of mail." The charge is dismissed.

(c) Regulation 5.3 states that: "The conveyor is liable for damages, loss and

theft of mail from the point of receipt of goods until delivery of the goods

is completed". The charge is dismissed.

3. As a result, CCC made the following recommendations to Council: "The complaint

is dismissed. Accordingly, no order is advised to Council." The CCC provided

advice to Council as to its functions in terms of section 17B(b) of the ICASA Act

(as more specifically detailed in the judgment).

4. On 11 December 2025, the Council of ICASA approved the recommendations of

the CCC as indicated in paragraph 3 above, having considered the reasons

advanced by CCC in their judgment.
