INQUIRY INTO THE ROLE AND RESPONSIBILITIES OF THE INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA IN CYBERSECURITY

- The Independent Communications Authority of South Africa ("the Authority")
 hereby gives notice of its intention to conduct an inquiry in terms of section
 4B of the Independent Communications Authority of South Africa Act, 2000
 (Act no. 13 of 2000), as amended ("ICASA Act").
- 2. The Authority is empowered in terms of the ICASA Act and the Electronic Communications Act No.36 of 2005 ("the ECA"), to make regulations to perform its functions. Section 4 of the ICASA Act provides that:
- "(3)(j) The Authority may make regulations on any matter consistent with the objects of this Act and the underlying statutes or that are incidental or necessary for the performance of the functions of the Authority".

- 3. The ECA seeks to establish a regulatory framework, in line with technological and economic developments, to promote convergence in the broadcasting, broadcasting signal distribution and telecommunications sectors.
- 3.1. Section 2(n) states that ICASA must promote the interests of consumers with regard to the price, quality and the variety of the electronic communications services;
- 3.2. Section 2(q) of the ECA states as one of the mandate of ICASA to "ensure information security and network reliability";
- 3.3. Section 36 (1) of the ECA states that "the Authority must prescribe standards for the performance and operation of any equipment or electronic communication facility, including radio apparatus."; and
- 3.4. Section 36 (2) further states that "such standards must be aimed at protecting the integrity of the electronic communications network."
- 4. The purpose of this the Inquiry is to determine the role and responsibilities that the Authority should play in relation to cybersecurity guided by the enabling legislation.
- 5. Following this notice, the Authority will follow the steps outlined below in the process of completing the inquiry:
- 5.1. The Authority publishes this Discussion Document to solicit comments from stakeholders on their views on the role and responsibilities that the Authority should play in relation to cybersecurity;
- 5.2. The Authority invites written submissions on the Discussion Document from interested parties. The closing date for submissions is 30 November 2018 at 16h00 at the Authority's Head Office at Block D, Pinmill Farm, 164 Katherine Street, Sandton. Submissions may be made by post, hand delivery, facsimile transmission or email. Submissions received after the submission deadline may be disregarded

- 5.3. The Authority may hold oral representation upon request by stakeholders in their written representatives.
