- (1) On 06 April 2018, the Independent Communications Authority of South Africa ("the Authority") published Draft Regulations for Community Broadcasting Services: Radio and Television in Government Gazette 41561, for comments.
- (2) In terms of the General Notice, interested parties were invited to make written comments by no later than 18 May 2018.
- (3) The Authority have decided to conduct extensive provincial workshops on the draft regulations from 15 May to 08 June 2018. However, the Authority deems it necessary to align the submission date for written representations with the dates for the provincial workshops.
- (4) Therefore, the deadline for the submission of written comments on the above is extended to 15 June 2018.
