A INTRODUCTION

1. This document sets out the reasons for the decisions of the Independent Communications Authority of South Africa ("the Authority") in relation to the applications to pre-register for community sound broadcasting service ("CSBS") and Radio Frequency Spectrum ("RFS") licences in the various district municipalities throughout the country.

2. The background against which the licensing process was conducted is as follows:
 - 2.1 In 2016/17 financial year, the Authority conducted a review of the licensing framework for community broadcasting services, which culminated in the publication of the Community Broadcasting Services Regulations ("the Regulations") under Government Notice R439 (Government Gazette 42323) on 22 March 2019.

 - 2.2 In the Community Broadcasting Services Regulations, the Authority stated the purpose as inter alia to prescribe the framework under which community broadcasting services will operate; registration, renewal, transfers, and amendments of community broadcasting licenses; governance and Management structures of a community broadcasting licensees; and the basic principles of community participation¹.

 - 2.3 On 26 July 2019, the Authority published a Notice lifting the Moratorium² on CSBS and RFS sound broadcasting licence applications.

 - 2.4 On 12 November 2019,³ the Authority published the Invitation to Pre-Register ("ITP-R") for CSBS and RFS. The closing date for the submission of applications was 31 March 2020.

- 2.5 The ITP-R included a list in Annexure C (Spare Community Broadcasting FM Frequencies) of FM frequencies that were available for community sound broadcasting services in district municipalities in various provinces.
- 2.6 On 24 January 2020, the Authority published an Erratum⁴ for the ITP-R in which it identified seven (7) frequencies that needed to be removed from the ITP-R and five (5) additional frequencies that needed to be added to the ITP-R.
- 2.7 On 1 October 2020, the Authority gave notice that, in response to the ITP-R, it had received applications to pre-register for CSBS and RFS licences. The Authority listed particulars of the applications received in the schedule of the notice⁵, and interested parties were invited to submit written representations on the applications. The closing date for the submission of such representations was set as 20 October 2020.
- 2.8 In response to the notice, the Authority received four (4) written representations from one member of the public in respect of the pre-registrations from: Wes' Gold FM, Bophirima FM, Baagi FM (West Rand Youth Development), and Radio Kingfisher.
- 2.9 On 2 November 2020, the Authority published a notice offering a second round of comments for written submissions in respect of applications received in response to the ITP-R⁶. The closing date for written representations was 13 November 2020 and the closing date for responses thereto was 24 November 2020. No written representations were received by the Authority.

B THE INVITATION TO PRE-REGISTER

3. As mentioned above, the Authority published an ITP-R for CSBS and RFS licences for the provision of community sound broadcasting services in the district municipalities in various provinces in terms of the provisions of section 17 of the EC Act read with regulation 4(5) of the Regulations. The ITP-R stipulated that:
 4. Applicants were required to comply with, amongst other things, the following:
 - 4.1 ensure that the original application together with, five (5) hard copies and 1 soft copy of the completed application were submitted to the Authority before the closing time. The closing date and time was later extended to 30 April 2021 due to the Covid-19 Pandemic⁷;
 - 4.2 each application had to be permanently bound, using either heat binding or spiral binding ⁸;
 - 4.3 each application was required to have a cover page indicating the name of the applicant, the licence being applied for and year of application⁹;
 - 4.4 the page(s) immediately following the cover page were required to be the contents page(s) which detail each section of the application and corresponding page numbers¹⁰;
 - 4.5 pages including the appendices were required to be numbered sequentially starting with the page immediately following the contents page(s) as page 1 and ending with the very last page of the application¹¹;

- 4.6 each volume had to have a cover page which specified the number of the part or volume¹²;
- 4.7 each application had to be accompanied by a non-refundable application fee of R3829.00¹³;
- 4.8 pre-registrants had to ensure that they applied for the correct frequencies as contained in Annexure C to the ITP-R¹⁴;
- 4.9 pre-registrants had to select the frequency(ies) in the geographic area in which the service is to be provided ¹⁵;
- 4.10 pre-registrants intending to self-distribute their broadcasting services must attach a copy of its electronic communications network services (ECNS) licence ¹⁶; and
- 4.11 pre-registrants appointing a licensed signal distributor must attach a copy of the agreement with that licensed signal distributor ¹⁷.
5. The ITP-R stated that "*non-compliance* with the provisions of the EC Act, this ITP-R and/or any applicable regulations will result in the rejection by the Authority of such *non-compliant* application" ¹⁸.
6. Annexure C of the ITP-R included a list of FM frequencies that were available for community sound broadcasting services in various district municipalities.
7. The information that was required to be included in the pre-registration application, amongst other things, was as follows:

- 7.1 proof that it is a Non-Profit Organisation that has been in operation for a period of two (2) years or more ¹⁹.
- 7.2 demonstration of community development and empowerment with respect to the community located within the intended service area ²⁰.
- 7.3 submission of the pre-registration notice as set out in Form B of the Process and Procedure Regulations ("Form B"), which must be accompanied by the following:
- 7.3.1 CV of Board members and Management ²¹;
 - 7.3.2 disclosure of interests of Board members and Management ²²;
 - 7.3.3 tax clearance certificate ²³;
 - 7.3.4 evidence of demand, need, and support for the proposed service including profiled community broadcasters in the coverage area and programming format ²⁴;
 - 7.3.5 projects reporting on Management, governance, and finances ²⁵;
 - 7.3.6 corporate governance and operational policies ²⁶;
 - 7.3.7 programming information, including details of the proposed programme service, the programme schedule, the format and content, including the balance between music and speech programming, where relevant, details of the proposed South African music output, details of the proposed news output, broadcasting hours and proposed languages ²⁷;
- 7.4 financial information, including the applicant's business plan, projected financial statements with capital and operating expenditure, details of total funding requirements and the sources
