### **1. LICENSEE**

The Licence is issued to:

- 1.1. Name of entity: Giyani Community Radio.
- 1.2. Name of the Station: Giyani Community Radio.
- 1.3. Control of the Licensee: Control shall vest in the Board of Directors of Giyani Community Radio.

### **2. LICENCE PERIOD**

- 2.1. The effective date of the Licence is 06 November 2017.
- 2.2. The Licence shall expire on 05 November 2022.

### **3. LICENCE AREA**

The Licensee shall provide services to Greater Giyani Municipality in the Limpopo Province as set out in the Licensee's radio frequency spectrum licence.

### **4. COMMUNITY**

- 4.1 The Licensee shall provide services to a geographical community residing within the geographic coverage as specified herein.
- 4.2 The Licensee shall provide for the participation of community members in the affairs of the station in the following ways:

- 4.2.1 The Licensee shall hold at least two (2) meetings annually with its community focusing on programming policies of the radio station.
- 4.2.2 The Licensee shall furnish the Authority with proof of such meetings as well as the attendance thereof by members of the community.
- 4.2.3 The Licensee shall hold an Annual General Meetings (AGM) for the following purposes:
  - 4.2.3.1 To provide feedback on the Licensee's compliance with licence conditions;
  - 4.2.3.2 To provide feedback on the Licensee's operational and financial performance, and any Special Annual General Meeting as and when required by the constitution; and
  - 4.2.3.3 To elect members of the controlling structure e.g. Board of Directors, Trustees etc. subject to the Licensee's founding documents.

## **5. PROGRAMMING**

### **5.1 The Licensee shall provide programming as follows:**

- 5.1.1 Format: 65% talk and 35% music.

## **5.2 News and information obligation:**

5.2.1 The Licensee shall broadcast a total of eighty (80) minutes of news per day, of which seventy percent (70%) shall be local news generated from the community, twenty percent (20%) shall be from Limpopo province and ten percent (10%) national.

5.2.2 Current Affairs shall be broadcast from Monday to Friday for sixty (60) minutes. The content shall be from Greater Giyani, Limpopo Province and nationally.

## **5.3 Local Content Obligations:**

5.3.1 The Licensee shall broadcast a South African music content of 45% and further comply with the South African music regulations.

## **5.4 Language(s) of broadcast:**

5.4.1 50% Xitsonga;

5.4.2 20% Tshivenda;

5.4.3 20% Sepedi; and

5.4.4 10% English.

5.5 The Licensee shall keep a log of programmes broadcast which must be submitted on a monthly basis to the Authority. A pro-forma of the log to be kept will be supplied by the Authority.




