1. INTRODUCTION

The Independent Communications Authority of South Africa ("Authority") has a statutory mandate in terms of the Constitution¹, the Independent Communications Authority of South Africa Act² (ICASA Act), the Electronic Communications Act³ ("EC Act") and the Broadcasting Act⁴, as amended, to regulate broadcasting activities in South Africa in the public interest.

The South African Broadcasting Corporation ("SABC") Limited derives its existence and mandate from the Broadcasting Act. The SABC was granted licences by the Authority to provide public sound and television broadcasting services.

Section 2 (u) of the Object of the EC Act, directs the SABC to ensure that in the provision of public broadcasting services-

- (i) the needs of language, cultural and religious groups;
- (ii) the needs of the constituent regions of the Republic and local communities; and
- (iii) the need for educational programmes, are duly taken into account.

Further, the SABC is governed by the Charter, as contained in Chapter IV of the Broadcasting Act. The Charter provides or empowers the Authority to monitor and enforce compliance with the Charter by the SABC.

It is within the above context that the Authority conducted a monitoring exercise, in order to determine the extent to which the SABC has complied with the provisions of the applicable legislation, the licence terms and conditions and the relevant regulations.

2. LEGISLATIVE FRAMEWORK

2.1. Performance Period

The Authority, in measuring compliance with the provisions of the applicable legislation, the licence terms and conditions and relevant regulations, takes into account the definition of the performance period as defined in the South African Television Content Regulations, as published in Government Gazette No. 28454, dated 31 January 2006. The performance period refers to the total number of hours between 05h00 and 23h00 every day. In line with this definition, recordings were requested from the SABC for the period September to October 2008, in order to determine compliance during the performance period.

2.2. South African Television Content Regulations

Clause 3.1 of the South African Television Content Regulations stipulates that a public television broadcasting licensee must ensure a minimum weekly average of 55% of its programming measured over a period of one year, during the performance period, consists of South African television content and that such South African television content is spread reasonably evenly throughout the south African performance period and prime time.

Clause 3.2 further provides that where a public television broadcasting licensee provides a broadcasting service which has more than one channel, that licensee must ensure that a minimum of 55% of its programming on each channel during the performance period, consists of South African television content which is spread reasonably evenly throughout the performance period.

Further, clause 3.3 states that in complying with its obligation in respect of clause 3.1 read with clause 3.2 above, the SABC must ensure that the minimum percentages outlined in the table below are adhered to.

2.3. Special Licence Terms and Conditions- Programme content per genre

The special licence terms and conditions for the respective licenses provide that the licensee shall in each financial year broadcast a certain number of hours during the performance period. The following table indicates the number of hours per programme genre to be transmitted by each television channel for the year under review (see Appendix A-SABC TV licences for further details).

3. RECORDING MATERIAL

The SABC provided the Authority with SABC 1 and 2 recordings from 05h00 to 18h00 for September 2008, which is not in line with the performance period requirement. This resulted in some of the programmes such as 7de Laan, which runs from 18h00 to 18h30, being cut short, ending a few minutes after 18h00. Outstanding recordings from 18h30 until 23h00, including October 2008, were requested from the broadcaster, however these could not be provided to the Authority as the recordings were no longer available due to the lapse of the 60 day period provided for in terms of section 53 (1) (a) of the EC Act which provides as follows:

'A broadcasting service licensee must-

on demand by the Authority, produce to the Authority any recording of every programme broadcast in the course of his or her broadcasting service for examination or reproduction, within 60 days from the date of broadcast'.

Due to the non availability of recordings from 18h00 to 23h00, the prime time period and the requirements thereof, as provided for in the licence terms and conditions for SABC 1 and 2, could not be monitored.

With respect to SABC 3, for the month of September 2008, the SABC submitted recordings for 22 days. The recordings for the period 01 to 07 September 2008 were however not submitted. The recordings for the period from the 08 September 2008 started at 12h00. For the month of October 2008, the SABC submitted recordings for 12 days, starting from 01 until 12 October 2008. No recordings were received from 13 to 31 October 2008. As with the situation in SABC 1 and 2 mentioned above, the outstanding recordings could not be obtained from the licensee due to the lapse of the 60 day period.

Consequently, the information contained in this report is an outcome of the actual content monitored in respect of SABC 1, 2 and 3. In addition, while this report is the outcome of material monitored, the Licensing and Compliance Division ("LCD") also took into account the SABC's Quarterly Reports (Quarters One, Two, Three and Four) submitted to the Authority for the 2008/9 financial year, of which summaries are captured below.

6.3.2 Language

SABC 3 is licensed to broadcast predominantly in the English language, but is required during the financial year 2008/2009 to broadcast 8% per week of its programme material in other official languages, other than English. The only programme that caters for other languages is "World Today" in which news is broadcast in Sesotho, Tswana and Afrikaans. For the months of September and October 2008, SABC 3 broadcast a total of 17 hours 3 minutes and 25 seconds of programmes in Sesotho, Tswana and Afrikaans languages. 7. OTHER OBLIGATIONS

7.1. Programming for people with disabilities

Section 2 (s) (iii) of the EC Act stipulates that broadcasting services viewed collectively should cater for the broad range of services, specifically the programme needs of children, women, the youth and the disabled. Further, the licence terms and conditions of the SABC TV provide that they must ensure that:

- 1. Reasonable provision is made for sign language translation during news bulletins transmitted in prime time and during other programme genres, and
- 2. People with disabilities regularly feature and participate in the programme material in accordance with the Integrated National Disability Strategy

There are no hourly requirements with regard to people with disabilities. From the monitoring done, there were no instances of non compliance with the regulations identified. Although there is still room for improvement in respect to the two clauses above, there are indications that SABC Television services strive to include people with disabilities in their programming. SABC 1 broadcasts a programme called "Shift" presented by a blind person, and SABC 2 broadcasts news bulletins, more especially during the afternoons, with sign language. SABC 3 broadcasts a programme called "DTV" devised for deaf people and the channel has a provision for sign language translation.

7.2. Advertising and Infomercials

The Regulations on Advertising, Infomercials, and Programme Sponsorship, published in April 1999, read with clause 9 of the licence terms and conditions, provide that the SABC may not broadcast more than an average of 10 (ten) minutes of advertisement per hour on the licensed service. Further, that the SABC may not broadcast advertisements in excess of 12 (twelve) minutes in any one-hour.

7.2.1. Advertisements

SABC 1

SABC 1 complied with the maximum 12 minute requirement with regard to advertising, save for the 13 September 2008, between 12h00 and 13h00, where 15 minutes and 27 seconds of advertisements was transmitted, and 29 September 2008, between 10h00 and 11h00, where 15 minutes and 2 seconds was broadcast.

SABC 2

SABC 2 complied with the maximum 12 minute requirement with regard to advertising, save for the 7 September, between 16h00 and 18h00, where 17 minutes and 45 seconds of advertisements was broadcast.

SABC 3

SABC 3 did not fully comply with the requirement of a minimum of 10 minutes and a maximum of 12 minutes per hour in respect of advertising. Non compliance with advertising requirements is reflected in the table below:

7.3. Independent Production





respect of its three television licences. Further, due to the fact that the information

submitted did not cover the entire performance period, the Authority cannot

conclusively deduce that the SABC did not comply with its licence terms and

conditions.

It is to be noted however that the information submitted by the licensee in its

quarterly reports indicated compliance with the requirements. All areas of concern as

articulated in this report, most of which could possibly be attributed to the challenges

highlighted with regards to the recording material received, will be communicated to

and addressed with the SABC.
